### Section 4. First-aid measures

#### **Description of necessary first aid measures**

**Eye contact**

### Section 5. Fire-fighting measures

Specific hazards arising from the chemical

: Highly flammable liquid and vapor. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. #### Methods and materials for containment and cleaning up

#### **Small spill**
